Dealer set-up is Thursday June 1,2023 from 12noon-7pm. All dealers must be a current member of the TNA, at least 21yrs of age and have a valid Sales tax number. Any balance is due by March 15, 2023. Mail your \$25 TNA dues to Lawrence Herrera in advance of the show. Application may be cancelled in writing and payment refunded prior to March 15, 2023. Cancellations made after March 15, 2023, will forfeit all money whether table is sold or not. EARLY BIRD BADGES ARE AVAILABLE FOR \$50.00. Table deposit \$100.00.
