Young Numismatist Programs Receive Generous Gift

Bringing the World of Coins to the Next Generation

s President of the TNA, I recently received an inquiry from John Schroedel in Little Rock, Arkansas. John indicated that he had a large collection of foreign coins that he wished to donate for the TNA's various programs for young numismatists. As I inquired about the coins and our correspondence grew, I soon began to understand how this very interesting man came to the decision to donate a lifetime of work to the next generation of collectors.



As a young boy, John had an early onset of hearing loss that made him largely dependent on his sight. Living in the quiet world of the hearing impaired, John soon found that his best studies were those in which he could easily absorb concrete information such as geography, history, and economics. He became an avid reader of books on these topics and eventually earned a doctorate in Sociology from New York University.

As a teenager he began his coin collection with Indian Head and Lincoln cents. His studies soon took him to the top of his class. In 1989 he started a collection of foreign coins as his sharp mind and acute sense of vision expanded his horizons and his primary collecting interest began to focus on foreign coins. He found these to be tangible examples of his favorite areas of study.

John worked for 25 years as a Research Professor within the Department of Vocational Rehabilitation at the University of Arkansas. His research included improving services for deaf and hard of hearing persons. It was representative of a lifetime of giving back to others. During this period he presented research results at about 75 professional conferences in 45 states and parts of Canada.



Imagine "my horror" when I read Jim Bevill's "From the President..." column in the Sep/Oct 2008 issue of The TNA News. I almost quit the ANA when their former Executive Director with a weak Board of Governors tried to use the ANA to further his own agenda. I DO NOT want to go through this again with the TNA!



2009 TNA ELECTION PROCEDURES

The following election procedures are set forth by the TNA By-Laws and the TNA Board. The 2009 election is for Officers and Governors to serve for the two (2) year period beginning after the 2009 TNA Convention and through the 2011 TNA Convention. The election is by secret ballot in a method and manner determined by the TNA Board in line with the By-Laws.

The five (5) statewide Officers are the President, First Vice President, Second Vice President, Secretary and Treasurer. Also being elected are the District Governors. Candidates for office no longer need to be nominated by another member or club, but only need to file for office with the TNA Secretary from December 19, 2008 until April 2, 2009. All candidates must be residents of the State of Texas and the candidates for District Governors must reside in the district they represent with the exception of District X where residents in the adjacent areas of New Mexico within 75 miles of the Texas border are eligible.

All candidates must be approved members of the Association in line with Section 2.02 of the By-Laws at the time of their filing for office. No member shall be eligible for the office of President until they have served in at least one elected office in the Association. No President or Vice President shall serve more than two (2) consecutive terms in the same office without a break in service. Any two (2) or more offices may be held by the same person except the offices of President and Secretary.

State Officers of the Association are elected by Members and Chapters of the Association. District Governors are elected by the Members and Chapters in their respective districts. There is no provision for write-in votes. There is no provision for a run-off in the event a candidate does not receive the majority of the votes. The candidate receiving the most votes shall be declared the winner of the election. In the event two candidates receive the same number of votes, the election winner will be determined by the outgoing Board of Directors.

Ballots shall only be sent out to those voters where there are contested elections. If there is only one candidate for office the office shall be deemed uncontested and the Board shall certify that candidate as elected to office at a Board Meeting prior to the Annual General Meeting. Ballots will be mailed to Members on April 7, 2009 and must be received (not post marked) by the Secretary by the end of the day May 2, 2009. Late ballots, altered ballots or ballots suspected of being altered or otherwise tampered with will not be counted. Ballots will only be mailed to approved members of the Association in line with Section 2.02 of the By-Laws. The results of the election will be formally announced at the General Membership Meeting in Fort Worth, Texas on May 17, 2009.

Candidates may also submit a biographical sketch, no longer than 150 words, suitable for publication in the Association's official publication and web site. Candidates names and any biography will be published in all issues of the Association's official publication prior to the end date of voting and also posted on the web site when received. (Candidates may also purchase appropriate political advertising in the TNA News.)

(From the By-laws - Section 2.02 APPROVAL OF MEMBERS. Membership shall be open to all interested persons fulfilling the requirements contained herein. Applicant's name shall be published in the official publication of the Association. If no written objections are received by the Secretary by the next issue [approximately 60 days] the applicant shall be admitted.)

TNA BOARD ME

These reports summarize the highlights of the Board Meetings and do not reflect the entire contents of the official Minutes. The official Minutes can be made available to the membership upon request as provided under the TNA By-Laws.

SEPTEMBER I, 2008 SPECIAL BOARD MEETING

President Jim Bevill called a Special Board Meeting by electronic means (e-mail) on September 1, 2008. He made a motion to appoint Kathy Lawrence to the Governor position in District 5 and May Garner to the Governor position in District 16. An issue was raised that a Governor must reside in the district they represent and that May Garner did not meet this requirement. The motion failed with 2 votes in favor, 10 against and 6 not voting.

SEPTEMBER 12, 2008 SPECIAL BOARD MEETING

President Jim Bevill called a Special Board Meeting by electronic means (e-mail) on September 12, 2008. He made a motion to amend the By-Laws to change the residency requirement for District Governors to include candidates residing in an adjacent district, to confirm Barry Carter as a District Governor in District 5 and to confirm May Garner as a District Governor in District 16. Neither of these individuals were residents of the districts that President Bevill's motion sought to appoint them. The issue was raised regarding appropriateness of changing the By-Laws to allow someone other than a resident of a TNA District to represent that district on the Board.

This motion failed with 3 votes in favor, 13 against and 2 not voting. (This is the motion that President Bevill referred to in his President's Column in the last TNA News issue.)

OCTOBER II, 2008 BOARD MEETING IN ROUND ROCK, TEXAS

The TNA Board met on October 11, 2008 at the Williamson County Convention Center in Round Rock, Texas. The meeting was chaired by President Jim Bevill.

The following Board Members were in attendance: President Jim Bevill, First Vice President Joe Olson, Secretary Hal Cherry, Treasurer Ray Legett and Governors Pat Curran, Tommy Bennington, Barbara Williams, Mike Egger, Gober Pitzer, Paul Garner and Ed Stephens. Also in attendance were Jerry Williams, ANA Representative, and Lawrence Herrera who was appointed to a vacant Governor position during the meeting.

A motion was made to waive the reading of the May 16, 2008 Board Meeting and approve them as published. President Bevill and Governor Garner brought up that the Secretary was including commentary in the Minutes that were not allowed according to Robert's Rules of Order. Governor Garner also presented his final report of the 2007 Fall TNA Coin Show held in Waco which he wanted included in these Minutes to which Treasurer Leggett objected to as to the wording. Governor Currant noted that in the past the TNA had been guided by Robert's Rules of Order but had not strictly followed them. After discussion, no changes were made to the Minutes and the Board approved them as published by a vote of 9 in favor and 1 against.

The Minutes of the September 1 and September 12, 2008 Special Board Meetings were individually approved as published, both with a vote of 10 in favor, none against and 1 abstaining. President Bevill noted in both cases that only the motion and results were needed and that all the commentary should be left out.

Secretary Cherry reported that the current membership was 661 members as opposed to 658 at the same time last year. Treasurer Leggett reported cash assets as of October 2, 2008 were \$135,897.06. For the first half of this fiscal year, receipts exceeded expenses by \$15,025.27.

Treasurer Leggett reported that the final financial report for the 2008 May TNA Show had been reviewed and approved with a net disbursement to the TNA of \$18,993.59. There were 178 tables sold and 164 dealers

in attendance. The TNA Board wants to thank all of the volunteers that helped make the show successful.

The 2009 TNA Show and Convention will be May 15 through May 17 again at Will Rogers Center in Fort Worth. David and Ginger Pike will again produce the coin show. An increase in the number of tables and dealers is expected.

Vice President Joe Olson, Chairman of the Houston Show Committee, advised that a Spring Show is probably not feasible due to the after effects of Hurricane Ike and that the committee is looking into a Fall Show for next year.

It was announced that an individual in Arkansas is donating approximately 11,000 foreign coins to the TNA for use with our various Youth Programs. Governor Curran is going to bring these coins to a suitable location in Texas where a committee can inventory them and make a decision on their best use with our various Youth Programs.

President Bevill announced that he is appointing Governor Garner as Exhibit Chair for 2009. He also announced that earlier this year he had appointed Governor Garner as TNA Historian with an assignment to write a history of the TNA in connection with the 50th Anniversary in 2010.

There was extended discussion about the issue of the vacant Governor's positions and changing the By-Laws to allow other than residents of those districts to become Governors. President Bevill made a motion to change the sections of the By-Laws regarding elections back to old wording that would allow this. However, the motion failed with 2 for and 7 against. Lawrence Herrera, a former Board Member and resident of District 5 was appointed as Governor of this district by a vote of 7 for and 1 against. Regarding District 16, there was discussion regarding it being combined with District 17 and the Board voted 6 in favor, none against and 1 abstaining to keep District 16 open and active as a district until a qualified candidate could be appointed or elected. Under old election rules, Governor Garner had been representing District 16 as well as 17 since District 16 did not have a TNA member chapter and therefore no candidate could be nominated for Governor from that District.

A committee was appointed consisting of Paul Garner,

Lawrence Herrera and David Burke to review our By-Laws to see if we were in compliance with state law and also to study redesigning the districts to more represent the membership and club activities. One reason President Bevill formed this committee was that based on research done by Governor Garner regarding Texas law, there was possibly some question on whether officers of non-profit corporations could be compensated. (Since the Board Meeting, your Secretary has consulted with his personal attorney whose opinion is that officers of non-profit corporations can be compensated.)

The Board voted 7 to 4 to establish a scholarship to the ANA Summer Seminar to be funded with \$1,250.00. The President will appoint a committee to establish the criteria and administer the scholarship. A \$2,000.00 donation will be given to the Numismatic Crime Information Center for the purpose of developing and reproducing materials for a statewide training system for law enforcement officers. This was approved 9 in favor and none against.

The TNA Library is infrequently used and President Bevill had determined that we had 60 items that the ANA Library did not contain. The Board voted 9 in favor and 1 against to donate these 60 items to the ANA Library and the ANA is in agreement to pay the shipping costs.

There was discussion about the President's Column in the September/October 2008 TNA News and the appropriateness of some of the content. Vice President Olson, Treasurer Leggett and Governor Barbara Williams all expressed their disappointment or concern on the matter and President Bevill responded that he had only received positive feedback. Treasurer Leggett questioned if he had the right of rebuttal and it was noted that the Editor and also the Web Master had previously been given editorial discretion as to what could be included in the TNA News and web site.

President Bevill had requested a copy of the TNA membership list including mailing addresses. It had previously been against the Board's policy to make this information available to anyone, including Board Members, due to privacy issues, particularly since our association is of numismatic collectors where privacy for security reasons is important. The Board voted 7 in favor and 2 against to maintain the current privacy policy.



From the President...

Round Rock to Little Rock - Progress abounds!

I've become very proud of many TNA accomplishments during my brief tenure as President, and am very pleased with several items which the board wholeheartedly supported at our recent meeting in Round Rock, Texas.

We voted to establish a \$1250 scholarship to the ANA Summer Seminar in Colorado Springs in 2009. This award for outstanding service to the TNA or member club will be selected by a three member committee of governors. Applicants should send a one page summary of their service accomplishments for consideration. Send the summary or essay to mercury225@sbcglobal.net and I will forward it to the committee for consideration. The deadline for submission is April 1, 2009.

Given the high profile nature of numismatic crimes in Texas, we voted to contribute \$2000 to the Numismatic Crime Information Center, a 501(c) 3 organization. The purpose of this gift is to develop and reproduce materials to implement a state wide training system on numismatic crimes for law enforcement officers in Texas. The donation was accompanied by a pledge of each TNA Officer and District Governor to assist Doug Davis in rolling out the training program to coin clubs and local law enforcement agencies in their respective communities.

The TNA board voted to donate sixty (60) items to the Dwight M. Manley Library at the American Numismatic Association in Colorado Springs. This donation will fill several gaps in the ANA's current collection and will bring these potential resources to a much wider audience. We also voted to appoint a new TNA Governor. Larry Herrera was appointed by the board to fill the interim position in District 6 (Dallas). Please join me in congratulating Larry on his appointment!

Perhaps the most interesting item at the meeting was the discussion of the pending donation of 5000 foreign coins from Mr. John Schroedel of Little Rock, Arkansas.

Largely by coincidence, Gov. Pat Curran of El Paso had planned a trip to Little Rock the following week and was invaluable in receiving Dr. Schroedel's donation on behalf of the TNA and bringing it back to Texas. You can read more about this generous donation of this stunning collection for the benefit of young numismatists in the article "Bringing the World of Coins to the Next Generation".

By the way, keep that coin club membership card handy. It's good for three days of free admission at the Greater Houston Coin Club's "Money Show of the Southwest" in Houston on December 5-7. I look forward to seeing you there!

SUNDAY CAN BE A GOOD DAY FOR A COIN SHOW

I hate to disagree with a fellow TNA Board member but sometimes it is good business for a coin show to continue being open on Sunday.

I think it all boils down to the location of the coin show and also how many other coins shows there are in the nearby geographical area.

In reviewing the number and location of the coins shows in Texas, if one lives near by the "Interstate 35 corridor" one could attend a coins show every month with just a little driving.

Now in my District X All of Texas in the Mountain Time Zone, there is but one club (the International Coin Club of El Paso) and one show a year.

That is in February, (this year the 20th through the 22nd) in the Shrine Auditorium.

The club sets up the room on Thursday and the dealers check in Friday Morning. Doors open to the public at Noon. The show is open till 6 PM Friday. Saturday and till 4 PM on Sunday. The nearest coin activity to this show is a show in Albuquerque or Tucson, both over 275 miles away. Except for in El Paso itself, there are no coin shops until you get to those other cities. Finally, being on the border, we do have many Mexican buyers come over on Sunday to shop and they are big buyers of Gold and Silver.


One of my personal beefs is that in some shows that are open Sunday, half the dealers are gone but still full admission is charged. We have solved that problem to a great degree by ONE not charging admission and TWO awarding a free table by draw, to the dealers who are still in place at 3:30 on Sunday.

With 2009 being the 100 anniversary of the Lincoln Cent and the 200 anniversary of Lincoln's birth, we are working with the public schools and the local banks to have the fist of the cents ready as well as exhibits on the history of the cent.

I invite all of you dealers to come, get a table and get in on the action and members, come as a tourist. You will see an auditorium full of numismatic activity on Sunday.

Editor's Note: Kathy Lawrence, editor of the Dallas Coin Club Newsletter and John Barber, editor of the "Double Shift", the Greater Houston Coin Club's newsletter received ANA literary awards for their publications. The items below are from the latest issues of these publications.

PRICES AT A B. MAX MEHL SALE IN 1918

Several months ago Ben Hong brought a receipt to the Dallas Coin Club meeting as a Show & Tell item. That receipt was for gold coins he purchased in the 1960s from a dealer in Houston. Recently I ran across a prices realized list from the B. Max Mehl sale that ended on December 18, 1918-ninety years ago. I thought it would be fun to share some of the results and compare the 1918 prices to those in the 2009 issue of the Red Book.

Mehl certainly handled some fantastic material during his career and this sale was no exception. The most expensive item in Mehl's sale was the 1875 \$3 gold in "magnificent brilliant proof." That coin sold for \$1200. The Proof-63 price listed for that coin in the Red Book is \$135,000.

Numerous private and territorial gold coins were offered in the sale. The 1850 "excessively rare 'Cowboy' \$10 gold" in brilliant uncirculated condition sold for \$500. That Baldwin & Co. coin is listed today at \$195,000 in uncirculated condition. Mehl's description certainly implies that he saw the potential that coin presented. Other offerings included Humbert, Bechtler, Mormon and Oregon gold pieces.

A complete set of Panama-Pacific Commemorative coins sold for \$245. Grab your calculator and a Red Book and calculate the total price the coins would command today. They have certainly appreciated nicely in value over the years.

Those of you who attended Stewart Huckaby's program on Russian coins several months ago or read the details in the newsletter will appreciate how much a platinum 6 rubles coin dated 1830 would likely fetch in today's hot Russian market.

More than a dozen U.S. Colonial era coins were sold, including the pewter Continental Dollar that was listed as "Crosby Plate VIII., Fig. 16." That coin brought \$10.25. Most of us could not even dream of buying one of those pieces of history today.

One Dallas Coin Club Member has a lovely Virginia Half Penny that his father purchased from B. Max Mehl some years later.

Fifty five coins were sold in that 1918 auction for a total of over \$7000. Nineteen of the coins went for less than \$10 each. If those same 55 coins were sold today, the total price realized would easily be several million dollars. That sale was just one of many that Mehl held during his career spanning over 50 years.



When the Dallas Coin Club was organized in 1928, Mehl became one of the Charter Members. He frequently brought examples of the more interesting material that passed through his establishment to Club meetings to show to the other Members. What a treat that must have been.

QUESTIONS FOR DR. COYNE

Excerpt from the "Double Shift", edited by John Barber

- 1) What was the first circulating coin containing gold struck by the U.S. Mint?
- 2) What modern U.S. coins were struck in a different year than the date on the coin?
 - 3) What is a "Castaing machine"? DR. COYNE RESPONDS:
- 1) The first circulating coin from the U.S. Mint to contain gold in its

specification was the Half Eagle (\$5.00) with small eagle reverse of 1795. Later the same year, an Eagle (\$10) piece was issued with a very similar design. Both coins lacked any notation of



the denomination anywhere on the coin. This was in the days when precious metal coins were presumed to contain their full value in metal. The Eagle was just proportionally larger than the Half Eagle. The U.S. Mint gave "free coinage", meaning that a depositor's submission was assayed, and then coins in that full weight

were returned to him. The mint bore the cost of production (and even supplied the copper alloy). The Quarter Eagles (\$2.50) were first produced in two small runs in 1796.

- 2) With a coin shortage raging and the conversion to clad coinage in progress, in 1965, the mint continued striking silver coins using 1964 dies while large quantities of clad coins were also being struck bearing the current date. Similarly, in 1966, there was not a prompt adoption of the 1966 date for dimes and quarters, as 1965-dated coins continued to be struck. When the coin shortage was deemed to be over in 1967, current dating was restored. Similarly, there are no quarters dated 1975; the Bicentennial design, bearing the date 1776-1976, was issued from 1974 through 1976. The "Cherrios" Sacagawea Dollars bearing the date 2000 were struck in 1999.
- 3) The Castaing machine is a special-purpose apparatus, invented at the Paris Mint, to put edge devices on planchets. The device is essentially two nearly parallel bars separated by a bit less than the diameter of the intended coin. One of the bars is fixed to the table, and the other bar is arranged to be moved by hand-crank or power so that the coin-to-be will roll between the bars while pressure is applied to the edge. The bars are engraved with appropriate inscriptions e.g. "One Dollar or Unit", or "One Hundred for a Dollar". A decorative design, or simple reeding could also be engraved on the Castaing bar and thus impressed into the edge of the coin. The U.S. Mint had such a machine in place in 1794 and continued to use it until the end of the Capped Bust Half Dollar series in 1836. By 1907, when lettered edges again appeared on U.S. coins, the mint had developed a more sophisticated segmented collar, and the edge lettering could be formed at the same moment as the obverse and reverse designs were applied, rather than in a separate operation with a Castaing machine.

Bringing the World of Coins to the Next Generation...

That travel provided him with opportunities to purchase foreign coins from more than 100 dealers coast to coast.

In short, his interest in coins made the world come alive for John. It was his wish that these coins could benefit from the educational aspects of a new generation of young collectors. Dr. Schroedel is now a retired professor from the University of Arkansas and recently made the very generous donation of almost 5000 coins from his foreign collection to the TNA for use in our various youth programs. These will include the Coins for A's program, the merit badge workshops for Boy and Girl Scouts, as well as the ever popular youth auctions at the TNA Coin Show and State Convention scheduled for May 15-17, 2009 and in subsequent years.

At first glance, a collection of foreign coins dating from the 1700s to the present day from over 400 political domains is an impressive feat. The collection arrived at the TNA with almost 5000 coins neatly housed in a series of single row boxes, each one meticulously labeled by geographic region. Each coin was in its own 2x2 holder, with the denomination, grade, Krause number, and country of issue neatly written on the holder.

Each box was organized by continent, and each continent organized by country and so forth. The collection included thousands of uncirculated coins and many valuable pieces remained in it at the time the donation was initially received by TNA Gov. Pat Curran.

The collection contains more than 200 coins from mainland France and its world wide colonies during World War II. Some of the coins represent France as an independent Republic before and after the Nazi occupation. Other coins were struck by the Nazis who controlled France during the Vichy period of 1941 to 1945. Several coins from Vichy-controlled French Indo-China were minted in Japan during 1940-1941. There are also 2 and 5 france

coins issued by the Allies that circulated in France and Algeria between 1944 and 1945. The design changes on these coins during the war reflect changes made by the powers which controlled the European continent.

An interesting aspect of the collection is that it includes tokens and currency from one of the world's most remote locations - Spitzbergen, islands near the Arctic Circle, which are owned by Norway and mined for its coal by Russia. These include four tokens dated 1993 minted in Leningrad (today's St. Petersburg) with face values of 10, 25, 50, and 100 rubles. In addition there are four scarce 1979 mine script notes with values of 1, 2, 3, and 5 kopeks which are not listed in editions of World Paper Money. These tokens and script notes were used by Rus-

sian miners to purchase items in the store owned by the Arkitikugol Mining Company. Also in the collection are two

> rare tokens from the De Beer's diamond Mining Company

Mining Company based in Johannesburg, South Africa.

Many of us are aware of the dilemma which many older collectors face when confronted with the fact that they may not have an in-

terested child or grandchild to which they can pass down their collection. It has also been said that genius often skips a generation. In John Schroedel's case, the genius was in the gift, and the beneficiaries are a generation removed. While the donated collection contained no gold and very few silver coins, the educational aspects of his generous gift are nothing short of priceless.

In a world filled with turmoil, greed and corruption, John's gift to the Texas Numismatic Association's youth programs exemplifies a wonderful example of good in the world. For his remarkable gift to education, all collectors, both young and old, should be grateful and we offer you our deepest thanks!

September Meeting - President Debbie Williams called the meeting to order at 7:05 PM.

Committee Reports: ANA 2010 National Money Show General Chairman John Post gave a brief report.

Election of New Members: David Patenaude nominated Phil Kelly for membership. Jack Allen seconded the motion and Phil Kelly was voted in unanimously as a new member. Welcome Phil!

Visitors: Phil Kelly (Colleyville), Kathleen Guthrie (Saginaw), Rick Johnson (Fort Worth), Gina Kessler (Arlington)

Communications: Gene Dixon and Bill Yates provided an update on Ed Hipps, who is recuperating from a stroke. His recovery is progressing and he attended one of the recent coin shows. John Post reminded the members of the Dallas and Mid-Cities Coin show to be held in Irving on September 13th and 14th. Bob Millard will recruit volunteers to help with the show. Ben Channel reported that the Name Badge Project has been quite successful, but that no decision has been made yet as to how to spend the proceeds from the program other than the intention is that the proceeds be used for youth-related activities. General Chairman John Post gave an update on the ANA 2010 National Money Show to be held in Fort Worth. John requested that members submit designs for the show postal cancellation, medal, and show logo. The ANA will select the final designs. Debbie Williams announced that John and Eve Barber (Houston) would be giving next month's educational program on the first U.S. Mint. Kathy Lawrence announced that she has accepted a position as a Currency Cataloger at Heritage Auction Galleries. Also, Kathy was recently appointed to the TAMS (Token and Medal Society) Board.

Old Business: Gary Andrews provided an update on the search for a replacement food service vendor to the Fort Worth coin shows now that Jeff and Anna Cecil have moved to Oklahoma. Gary has been negotiating with a vendor for the November show. Gary also made a plea for members to volunteer for various club activities and get more involved in the club. John Post reported that he would take over Jeff Cecil's responsibilities to coordinate the electrical connections for the Fort Worth coin shows at the Lockheed Recreation Center.

New Business: Secretary: Debbie Williams announced that Richard Moody has resigned as Secretary and that Walter Fabisiak has agreed to be Acting Secretary for the remainder of this year.

2009 Elections: Debbie Williams appointed a Nominating Committee for the 2009 elections to be held at the November Business Meeting consisting of Bill Yates, Jack Allen, and Bob Millard. Debbie asked that any members who are interested in

running for office contact one of the members of the Nominating Committee. Bill Yates reported that Dennis Wynn has agreed to run for Treasurer again if another candidate cannot be found. The Club will have to approve a waiver allowing Dennis to serve a third consecutive term as Treasurer.

Educational Program: Stewart Huckaby presented a program on Proof-Like (PL) Coins and circulated several examples of coins that have been graded as PL or DMPL. He explained that typically the first few hundred coins struck from a new or recently polished production die will usually exhibit some degree of a mirror or proof-like surface. These surfaces are characterized as: Satin or satin-like, Semi-Proof-Like, Proof-Like, Deep Mirror Proof-Like (DMPL).

Various designations are given by the grading services: PL means proof-like; DMPL is used by PCGS to designate deep mirror proof-like coins; DPL is used by NGC for deep mirror proof-like coins

The designations may only be given to one side of the coin if one side of the coin merits the designation but the other side does not. The most commonly collected proof-like coins are the Morgan dollars.

Stewart passed out a fact sheet showing the PCGS and NGC population reports of the most common dates of Morgan dollars.

James Halperin's book, *How to Grade U.S. Coins*, was recommened along with http://www.coingrading.com/ for more information.

Mid-Cities Coin Club

September Meeting - The meeting was called to order at 7:07pm by President Bob Millard with 14 members and 1 guest, Garry Fellers, present. Garry inquired about joining the club.

Show And Tell: John Post showed a Canadian proof set of silver coins, including the only \$4 coin made in Canada. Garry Fellers has a 1903 Phillipines proof set. Al Garrity showed a CU \$5 star note. Russ King found a proof Kennedy half in a roll of circulted half dollars from his bank. David Patenaude displayed some 1988 high-grade Krugerands. Mike Grant passed around a 1 oz silver bar that had been made into a love token with a 40pt diamond set into it.

New Business: Bob asked members to consider running for club officer or director.

It was suggested that we approach the Waterford to ask residents to come tell us about unusual places they've lived or visited, or unusual experiences. The coin club members agreed that we are interested in hearing from and about the residents.

Program: Bob Millard brought some MPC's (Military Payment Certificates). The first US 'MPC's' were the over-printed Hawaii notes and gold-seal notes used in North Africa. After WWII, rather than pay soldiers in US money on foreign bases and risk intervening in that country's economy, the military decided to print

its own 'money' which soldiers could use on base. It also prevented US currency from migrating into black markets. Different MPC designs ("series") were issued in different countries, and would be changed periodically.

It was estimated that, by the end of WWII, more than \$525 million in US currency had been diverted into other economies, both legitimate and otherwise -- the equivalent of \$6 billion in today's dollars.

The definitive book on the subject was written by Fred Schwan, who piqued Bob's interest at an ANA Summer Seminar. MPC's can be collected by series and/or denomination. Replacement notes are lacking the letter at the end of the serial number instead of having a star. Designs include Lady Liberty, submarines, airplanes, and other subjects. In some areas, MPC's were used like challenge coins or 'short snorters.'

Northeast Tarrant Coin Club

September Meeting - The meeting was opened by Vice-President Don Noles at 7PM. There were 31 members in attendance.

Announcements: Nominations are now open for club officer positions. The annual election will be in November. Please see Jack Gilbert if you would like to be on the selection committee.

October Meeting - The meeting was opened by President Jack Gilbert at 7PM. There were 52 members and guests in attendance. He welcomed visitors from Boy Scout Troop 32 who were visiting to help fulfill the requirements for the coin collecting patch. Kevin Conklin joined as a new member.

Announcements: The annual election will be held during the November meeting. John Black, Jerry Stuart, and Steven Lehr are on the ballot for director positions.

Interesting finds: John Post brought a wooden medal for the US Centennial Exposition in 1876. It is still in the original box. Merle told us the he saw a slabbed half cent in AG condition at the Arlington coin club meeting.

Richard Wallace and Robert Shultz gave the evening's educational presentation on the history of coins and coin collecting. They discussed how coins were minted, materials that coins are made from, collecting by type sets, date sets. They discussed coin grading methods. Old Business: Rob reminded everyone that the club Christmas party will be held at Luby's Cafeteria on December 11 at 6 PM. Rob brought up the fact that we had forgotten to discuss election of officers for the next year. Several members said that "if it ain't broke, don't fix it," so a motion was made and approved to continue with the same slate of officers for next year. A question was then raised as to why our club was a stamp and coin club since we never discuss stamps and the city already has a stamp club. Bryan Sweitzer brought an 1850 large cent which was made exactly one century before his birth in 1950. According to Bryan, the coin had been given to him at an early age with a statement that he was born in the wrong century. Bryan did not remember who had given him the coin, but he has always kept it and it was instrumental in his becoming a coin collector. Tony Zupkas said that it had been a major challenge to pick just one favorite coin for show-and-tell. He said it was kind of like trying to pick your favorite movie – there are just too many to pick from. So, Tony brought two coins that were of interest to him. One, which has always been one of his favorites - a Spanish Pillar Dollar, which according to Tony, has always been the first coin mentioned in the Red Book due to its importance in our nation's history. The coin was accepted as a medium of exchange in our country in Colonial times and eventually served as the basis for our own dollar coin. Per Tony, many sources feel that the banner that is wrapped around the pillars on the coin was the inspiration for the dollar mark. The coin was dated 1761. The other coin that Tony brought was a 1971 Panama 20 Balboa silver proof. He cited a recent program where he talked about one of the smallest world coins, called a Panama pill. In contrast, the 20 Balboa piece is one of the largest of world coins. The 20 Balboa contains almost 4 troy ounces of silver. Rob Robinson brought two half cents to illustrate a modernization of coin production that took place in the late 1820's through the mid 1830's at the US Mint. The two coins were dated 1829 and 1832. The 1829 had been made using an open collar while the 1832 made using the more modern closed collar which is still used today. He pointed out that changing to the closed collar method of coin manufacture produced a coin that was more round and with a higher and smoother rim, which not only made the coin look more refined, but improved the stackablility and wear of the coins. According to Rob, the closed collar was first used in 1828 in the production of dimes. In 1829, it was used with the half dimes and gold quarter and half eagles; in 1832 with the half cent, and in 1834 with the large cent. The closed collar wasn't used to mint half dollars until 1836. Rob passed both coins around the room along with a glass for everyone to see first hand the improvements made when comparing the two half cents.
